Nomination Notice 提名須知

Aim 宗旨

The Hong Kong Jewelry Industry Outstanding Achievement Award is held every ten years by the Hong Kong Jewelry Manufacturers' Association (HKJMA). Its purpose is to award those with extraordinary contribution to the Hong Kong jewelry industry and to celebrate their professional achievements. It aims to set a role model for fellow jewelers and contributes to the overall economic development of Hong Kong.

Eligibility 申請資格

Nominator 提名人

- i) Nominators must be Hong Kong permanent residents;
- ii) Nominators must hold a current position in a Hong Kong registered company;
- iii) The company to which the nominator belongs does not necessarily have to be a member of the Hong Kong Jewelry Manufacturers' Association.
- i) 必須為香港永久性居民及持有香港身份證;
- ii) 必須為香港珠寶業在職人仕;
- iii) 毋須為「香港珠寶製造業廠商會|會員。

Nominee 候選人

- i) Candidates must be Hong Kong permanent residents;
- ii) The company to which the candidate belongs must be registered in Hong Kong;
- iii) The company to which the candidate belongs does not necessarily have to be a member of the Hong Kong Jewelry Manufacturers' Association.

- ii) 必須為香港珠寶業人仕;
- iii) 毋須為「香港珠寶製造業廠商會」會員。

Judging Criteria 評審準則

- 40% | Achievement in the jewelry industry
- **40%** | Contribution to the jewelry industry & community
- 10% | Education and professional knowledge
- 10% | His / Her integrity

- 40% | 於珠寶業之傑出成就
- 40% | 對行業及對社會之貢獻
- 10% | 珠寶業專業知識 / 學歷
- 10% | 個人品格

Nomination Restrictions 提名限制

- i) The members of the judging panel, organizer and their staff shall not nominate candidates for the competition;
- ii) Each nominator can only nominate one person as nominee; meanwhile, each nominee can only be nominated by one nominator;
- iii) Past award winners are not eligible for nomination.
- i) 評審委員會成員、主辦機構及其職員不得提名候選人參選;
- ii) 每一提名人只可提名一位候選人,同時一位候選人只可以被一位提名人提名;
- iii) 過去兩屆之得獎人不能再被提名及獲獎。

Nomination Procedures 提名程序

- i) Each nomination should be completed using the designated form and signed by the nominee and the nominator;
- ii) Please submit a recent photo of the nominee (no older than six months);
- iii) Profile of the company to which the nominee belongs;
- iv) The supporting documents required of the nominee, including past awards, honors or professional qualifications, etc., to prove the nominee's achievements in the business and relevant professional knowledge, and a company's structure chart to show the nominee's position;
- v) The closing date for the submission is **24th August**, **2018**, **Friday**. Please return the completed nomination form and the supporting documents to HKJMA office. (**Unit G, 2/F, Kaiser Estate Phase 2, 51 Man Yue Street, Hunghom, Kowloon**);
- vi) HKJMA reserves the right to request both nominator and nominee to provide the original of any supporting documents.
